IN CONSIDERATION of being given the opportunity to enter in run/walk, I, for myself, my personal representatives, assigns, heirs and next kin:

1. ACKNOWLEDGE, agree and represent that I understand the nature of run/walk activities, and that I am qualified, in good health and in proper physical condition to participate in such activity.
2.
